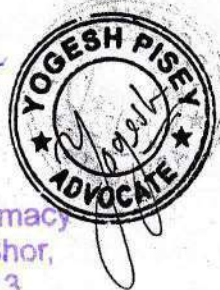

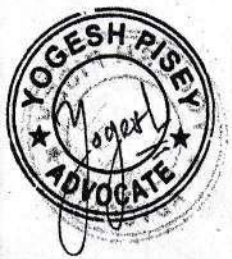

In accordance with the approval given by Pharmacy Council of India, New Delhi approval is being given to start new B.Pharmacy and M.Pharmacy courses course on permanent unaided basis as mentioned in the attached Annexure from the academic year 2022-23, subject to the following terms and conditions :-

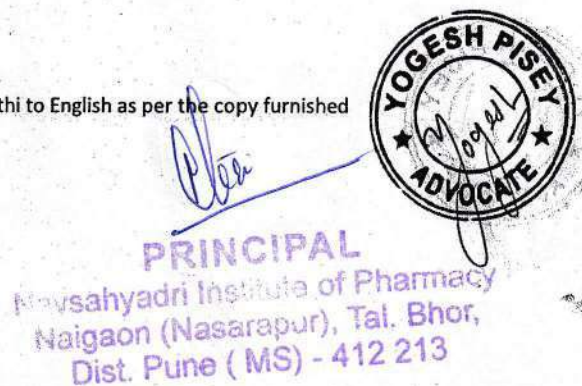
Terms and Conditions

- 1) The said approval shall be on permanently non-aided basis.
- 2) In the present case the concerned institution shall be bound to fulfil the conditions prescribed by the All India Technical Education Council as well as prescribed by the Government Decision dated May 21, 1983. The admission capacity of the institute for the said course will be as mentioned above.
- 3) The Institution has to enter into an agreement that all the terms and conditions prescribed by the Government as well as those prescribed by the All India Council of Technical Education are accepted, and the relevant documents and formalities are to be completed satisfactorily with the approval of the Director, Technical Education, Maharashtra State, Mumbai
- 4) The concerned institution should pay the necessary accumulated deposit to the joint account with the Director, Technical Education and fulfil other legal matters.

- 5) Admissions to the said degree and post graduate courses shall be done as per the admission rules/methodology of the respective courses approved by the government.
- 6) If the concerned institutions charge more than the education fee prescribed by the Fee Regulatory Authority, action will be taken against the concerned institutions as per Maharashtra Educational Institutions (Prohibition of Capitation Fees) Act, 1987.
- 7) The institute should appoint full time teaching staff and other technical staff as per the government rules to run the course. They should be given the salary and allowances as per rules. So also, if there are any complaints to the government from the students and regarding the salary and allowances of the teaching staff and other employees, strict action will be taken against the institution.
- 8) The books, periodicals required by the library in the institute must be procured as per the standards of All India Technical Education Council. Also, in order to make full use of the library for the students, it is necessary to provide textbooks to the students in the library, so also it is required to maintain all educational facilities (eg laboratories, library, classrooms etc.) for the students as per All India Technical Education Council Standards.



9) Regarding ragging, Hon. The directives of the Supreme Court and the Maharashtra Prohibition of Ragging Act, 1999 will need to be strictly implemented in respect of ragging.

2. Apart from this, other terms and conditions laid down by the Director, Technical Education, State of Maharashtra, Mumbai and the concerned University shall remain applicable.

3. Institutions which have not paid the processing fee to the Director, Technical Education, State of Maharashtra, the same should be collected from the institutes before final approval by the Director and the Director, Technical Education should issue necessary orders within the next 10 days to include the course as per this government approval in the centralized admission process.

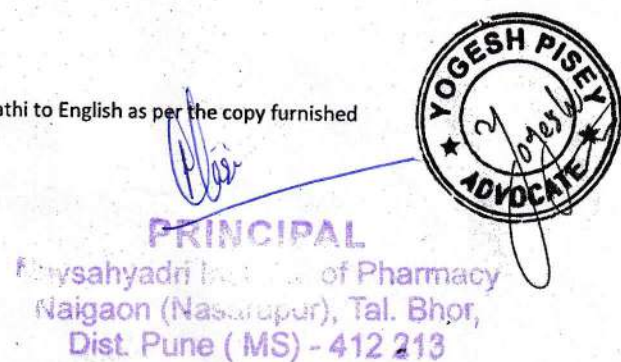

PREFACE,

According to the list received by the Directorate of Technical Education from the All India Council of Technical Education, New Delhi regarding New Institutions of Vocational Courses in the State from the academic year 2017-18, the Director, Technical Education has submitted a proposal for Government approval through the above reference letter. Pursuant to the approval given by the All India Council of Technical Education, New Delhi in the present

case, as per the proposal submitted by the Director, Technical Education, in view of the judgment of the Court dated 14.08.2015 passed in Writ Petition No. 4586/2015, the issue of Government Decision regarding the approval of the Government to start colleges of new Degree / Post Graduate Degree Courses as indicated against their names in the Annexure "A" was under the consideration of the Government.

GOVERNMENT DECISION:-

Pursuant to the Government Decision approved by the All India Council of Technical Education, New Delhi, approval is being given to the institutions mentioned in Annexure "A" to start new Degree / Post Graduate Degree Courses College as shown against their names from the academic year 2017-18 subject to the following terms and conditions;

1. The said approval shall be on permanently non-aided basis.
2. In the present case, it shall be binding upon the concerned institution to fulfil the conditions prescribed by the All India Technical Education Council as well as prescribed by the Government Decision dated 21st May, 1983. The admission capacity of the institute for the said course will be limited as mentioned in Annexure-"A".
3. The Institution has to enter into an agreement that all the terms and conditions prescribed by the Government as well as those

prescribed by the All India Council of Technical Education are accepted, and the relevant documents and formalities are to be completed satisfactorily with the approval of the Director, Technical Education, Maharashtra State, Mumbai.

4. For the said diploma courses, the concerned institute must take affiliation of Maharashtra State Board of Technical Education, as per the provisions of the Maharashtra Public Universities Act, 2016.
5. The concerned institution shall pay the necessary processing fee and accumulated deposit in the joint account to the Director, Technical Education, State of Maharashtra, Mumbai and fulfil other legal matters.
6. Admission to the said degree and post-graduate degree course will be done as per the admission rules/methodology of the respective course approved by the Government.
7. If the concerned institutions charge tuition fees more than prescribed by the Education Fees Committee, action will be taken against them under the Maharashtra Educational Institutions (Prohibition of Capitation Fees) Act, 1987.
8. It shall be mandatory for the institution to obtain the prescribed approval of the Pharmacy Council of India, New Delhi as per the provisions of Section 12 of the Pharmacy Act, 1948 before the completion of the final year of the students in their institution.

9. The Institute should employ full-time teaching staff and other technical staff to run the course and pay salaries and allowances to the staff as per the Government rules. So also, if any complaints are received from the teaching staff and other employees regarding the salary and allowances and the students to the government, strict action shall be taken against the institution.
10. The books, periodicals required by the library in the institute must be procured as per the standards of Maharashtra State Board of Technical Education. So also, in order to make full use of the library for students, it is necessary to provide textbooks to the students in the library. So also all educational facilities (eg laboratories, library, classrooms etc.) are required to be provided to the students as per All India Technical Education Council standards.
11. It is necessary that, regarding ragging, the directives issued by the Hon'ble Supreme Court and the Maharashtra Prohibition of Ragging Act, 1999 should be strictly implemented.
12. Apart from this, other terms and conditions prescribed by the Director, Technical Education, Maharashtra State, Mumbai and the concerned University shall remain applicable.
13. Institutions which have not paid the processing fee to the Director, Technical Education, State of Maharashtra, the same should be recovered from the institutions before final approval by the Director.

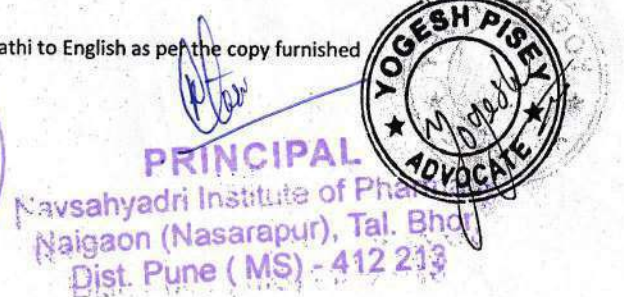
